Principals, Deputy Principals, Heads of Special Education Services, Heads of Curriculum, and other classified officers in the profession of Queensland State school leadership in special education who are **in acting positions for over one semester** in a Queensland State school (in which instance Ordinary Membership is limited to a period of one year being the year in which they hold the relevant position); **and those who have held substantive positions** as Principals, Deputy Principals, Heads of Special Education Services, Heads of Curriculum, and other classified officers in the profession of Queensland State school leadership in special education **but who currently occupy other administrative roles or hold positions in regional offices, central office or are on secondment.**
